OFFICE ORDER

No. GIS/PP/1054/2008/37: As per power conferred in the sub-section (2) of section 6 of the "Assam Non-Government Educational Institution (Regulation and Management) Act, 2006" and Rule 5 of the "Assam Non-Government Educational Institution (Regulation and Management) Rules, 2007" and as per decision of the Administrative Recognition Committee constituted under sub-section (1) of Section 7 of the "Assam Non-Government Educational Institution (Regulation and Management) Act, 2006", the Non-Government Educational Institution named below is hereby provisionally registered pending enquiry/ inspection as required for final registration of the institution:

2. This order shall be valid for 6 months only within which the School/ Junior College authority shall have to apply for final Registration in Form-II together with all supporting documents through the respective Inspector of Schools.
3. As per section 10 of the "Assam Non-Government Educational Institution (Regulation and Management) Act, 2006" and Rule 11, 12, 13 & 14 of the "Assam Non-Government Educational Institution (Regulation and Management) Rules, 2007", all the conditions are to be fulfilled within the period of 6 months.
4. As per sub-section (i) (b) of the "Assam Non-Government Educational Institution (Regulation and Management) Act, 2006" required land document (Registered deed or Govt. allotment order), possession certificate, completion certificate of buildings, certificate of fire safety measures etc. are to be produced.
5. As per section 14 of the "Assam Non-Government Educational Institution (Regulation and Management) Act, 2006" and Rule 16 of the "Assam Non-Government Educational Institution (Regulation and Management) Rules, 2007", a copy of the Scheme of Management is to be furnished.
6. As per section 12 of the "Assam Non-Government Educational Institution (Regulation and Management) Act, 2006" and Rule 15 of the "Assam Non-Government Educational Institution (Regulation and Management) Rules, 2007", there should be a Managing Committee a list of which must be submitted along with the application for final registration as per Form-II.
7. As per section 19 of the Act, no compulsory donation shall be levied or collected from any student of his/ her parents/ guardians.
8. As per section 20 of the Act, the Inspector of Schools of the district or his nominee is authorised to enter the school campus and enquire/ examine/ inspect with or without prior information.
9. As per sub-section (4) of the section 18 of the "Assam Non-Government Educational Institution (Regulation and Management) Act, 2006" and Rule 34 of the "Assam Non-Government Educational Institution (Regulation and Management) Rules, 2007", 5% seats must be kept reserved for the meritorious pupils hailing from poor families.
10. In pursuance of this order, it has become mandatory on the part of the above-mentioned Non-Government Educational Institution to furnish the audited accounts with details breakup of income and expenditure by the 31st day of March of each year as required under section 22 of Act and rule 32 of the Rules, submission of list of property as per Form-V as required under section 23 of the Act and rule 33 of the Rules including other returns as and when required.
